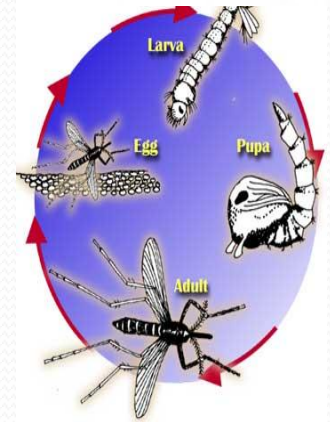

Skin So Soft

Step 1:

Physical Barriers

Step 1:

When weather permits, put your child in long sleeves. Light-colored, loose-fitting clothing can keep your child cool in the summer months and prevent mosquitoes from biting legs and arms.

Q: What can you do with bubble wrap other than pop it?

A: Bubble wrap regulates temperature. It will help retain cold as well as heat. Use bubble wrap to:

- Insulate your pipes and plants in the winter.
- Pot luck: next time you are attending a covered dish or pot luck party, wrap the dish, cover and all, in bubble wrap. It will keep food hot, make it easy to handle without oven mitts, and prevent breakage.
- Freezers: if you have a large freezer use bubble wrap to stuff the empty regions of your freezer to hold in the cold. When you open the door, the temperature will drop less, and the compressor won't kick on as much. You will also reduce energy consumption.
