

Gambusia, or mosquitofish, feed on mosquito larvae and are used all over the world to help control mosquito populations. Dragonfly larvae, called nymphs, eat mosquito larvae, and adult dragonflies prey on adult mosquitoes. Some towns in Maine release dragonflies every summer as a natural form of mosquito control.
