

The City's Environmental Health Services Department was recognized Texas Environmental the Health Association (TEHA) with the Award of Excellence in October 2012. This award recognizes Environmental Health Programs throughout Texas that achieve a high degree of professionalism and commitment to the communities they serve. The City of South Padre Island Environmental Health Services Department (EHSD) has been a member in good standing with TEHA for 11 years.

## WAVE Achieves 2nd Highest Ridership in the State

According to the FY2012 Texas Rural Transit Districts Peer-To-Peer Comparison and Performance Data reports, The WAVE had the second highest ridership among the state's

39 rural systems. The only system with higher ridership has a population of almost 62,000 and covers 248 square miles. The WAVE's total ridership for FY2012 was 593,404. The average ridership for all rural systems in Texas for FY2012 was 181,017.

## **EHS Awarded 3rd Consecutive Perfect Score**

For the third consecutive year, the Texas Department of Agriculture awarded the Environmental Health Services Department a perfect score on their Vector Control Inspection. The City has three Noncommercial Political Pesticide **Applicator** licensed officers and all their records, type and storage of pesticide, pesticide safety, M.S.D.S. sheets and proper use of pesticide were found to be in compliance with all federal and state regulations. ## **Citywide Training**

Supervisor Training was held September 2013 at the Convention Center for City staff. This was a great training; we hope that the supervisors will use some of the new techniques presented to assist with their daily supervisory duties. The title of the course was Effective Supervision, Build or Refresh Your Skills for Supervisory Success. The main objectives of this course focused on making the transition from co-worker to supervisor, coping with supervisor challenges and managing your time and stress. Forty City employees attended this training.

#### **Annual Total Compensation Statements**

Each full-time employee received an individualized Total Compensation Statement in February 2013 in their payroll check. The statement details the total compensation package, including all benefit costs and salary for each employee. This is a huge task for the HR division. A special thanks goes out to Araceli Sanchez for completing the majority of this project on her own. This is the third consecutive year the benefit statements have been created.

## **Workplace Survey**

The HR division held meetings throughout January 2013 with all employees to conduct the Annual Workplace Survey for the City Manager. The survey was anonymous and we used an election ballot box to collect all surveys. Once all surveys were complete, a comprehensive document was created by the HR division and provided to the City Manager. The workplace survey is conducted annually to identify any workplace issues or concerns.

#### Deer Oaks **Employee Assistance Program**

Last year, the City formalized its Employee Assistance Program (EAP) with Deer Oaks, a behavioral health organization, to help employees and their dependents assess and cope with work-related concerns or personal issues that may be affecting their well-being. We are proud to say that our current utilization rate is 11.77%, which is well above the national average of 4-6%. A big thanks goes out to Maria Norwood, who is tasked with communicating this program to employees each week by reminding everyone of the many free services available.

#### TML IEBP Regional Meeting

The City of South Padre Island hosted the 2013 TML IEBP (TML Intergovernmental Employee Benefits Pool) Regional Meeting on May 9 at the Convention Centre. Maria Norwood and Araceli Sanchez attended this meeting. Topics included updates on upcoming health changes and benefits, as well as new tools that will facilitate the provision of health benefits to employees.

### **Spring Break**

The HR division processed new hire orientation for 108 employees to work during Spring Break this year.

For each employee, the HR division must process the application, paperwork, conduct a background screening, document drug testing, report to the State of Texas Office of the Attorney General and report to E-Verify. E-Verify is a system utilized that reports individuals who are not authorized to work in the United States based on the documents submitted for verification on the I-9 Form. Maria Norwood, Araceli Sanchez, and Wendi Delgado are extremely busy during late January and February getting everyone ready to work in the Police, Fire, Environmental Health, and Public Works Departments.

Press releases were sent out regarding the program and statistics were recorded from February 16, 2013 -March 10, 2013. The Court mailed more than 6,000 letters to all of those with warrants with the City. Crystal Martinez and Cindy Garza-Vasquez worked extremely hard to get this program together and prepare the massive amount of warrant letters that were released on February 15th, 2013. This program was extremely successful, with a total collected of \$38,891.25. The Municipal Court Staff did a tremendous job and will continue this program next year.

# Development Services



### Parks & Open Space Master Plan

The Department of Development Services has been working on Parks and Open Space Master Plan and it is waiting for public input stages. This is a systematic approach to provide high quality services and opportunities for all residents, business owners, and their future generations.

## Amendment to the Zoning **Ordinance**

Development Services helped assign zoning districts for the properties that were annexed in December 2012. The Department is reviewing certain sections of the zoning ordinance to improve living quality of residents; to accommodate better parking locations; and to fine-tune with the recently adopted Form-Based Code (Padre Boulevard & Entertainment District Code). This effort is expected to evolve into the development of a unified development code.

### **Comprehensive Plan**

The City's Comprehensive Plan adopted in 2008 requires an evaluation with necessary updates every five years or less. This fiscal year, Development Services began the process of updating the plan, that was orginally created for the year 2020; the updated version will extend to the year 2025. The process includes: 1- Data Collection & Analysis, 2- Vision Sessions with the Public, 3- Staff's Internal Review, 4- Recommendation of Planning & Zoning (P&Z) Commission (and/ or Joint Workshop Sessions with the P&Z and the Council), and 5-Adoption by City Council.

## **Welcome Package**

#### GIS

The Department of Development Services updated the Zoning District Map and published the City Map Book with the current zoning delineation. Flood Insurance Rate Map (FIRM) comparing the currently effective 1999 version and the new Digital Flood Insurance Rate Map has also been prepared.

### **Economic Development**

The City of South Padre Island is committed to the promotion of high quality development in the City and to an ongoing improvement in the quality of life for its citizens. Insofar as these objectives are generally served by the enhancement and expansion of the local economy, it is the City of South Padre Island's intention to provide stimulation measures for economic development on the island. The Department of Development Services has been assisting the Economic Development Corporation (EDC) in developing Economic Incentives Policies (per Chapter 311 and 312 of Texas Tax Code and Chapter 380 of Local Government Code) and prepared the application forms.

# **Environmental Health** Services

#### **US FDA Grant**

The US Food and Drug Administration (FDA) awarded \$2,500 grant to the SPI Environmental Health Services (EHS) Department for the second year in a row. The grants are awarded to municipalities that are working on the Voluntary National Retail Food Regulatory Program Standards. to provide financial support for equipment, training and education opportunities for staff.

#### **New Brush Ordinance**



To further help beautify the island, the City Council approved a new ordinance that regulates when brush and bulky items may be placed on the right-of-way for removal by Allied Waste. Residents that have an active account with Allied Waste may place brush and bulky items on the right-of-way beginning on the 25th day of the month through the last day of the month; the brush and bulky items are collected on the first three workdays of every month. EHS staff patrols the city to ensure all piles of brush and bulky items are removed and our streets look clean and aesthetically pleasing.

#### **Food Safety Awareness**

EHS participated in Food Safety Awareness Month in September. The Mayor read a proclamation at the September 4, 2013 City Council meeting. The goal is to educate the public on the importance of preventing foodborne illnesses and this year, the campaign spotlighted the increasing importance of food allergen awareness brought attention to the restaurant and foodservice industry's commitment to excellence in all aspects of food safety education and training.

### **Recycling Program Enhancements**



Since its inception four years ago, the City's recycling program has enhanced its services in partnership with Allied Waste. A new waste recycling truck that is specifically designed for recycling and can hold 40 yards of material with five side-load compartments was added this past year. This is a great addition to the existing two trailers that carry eight containers each for the collection of paper, plastic, aluminum, cardboard and tin. Also, drop off services are now available every Saturday, instead of twice a month. Internally, the City is also recycling ink and toner cartridges, fluorescent and compact fluorescent lights, batteries that contain lead and acid, cell phones, electronics, tires and scrap metal. The materials collected would normally occupy hundreds of yards of landfill space, but through the recycling program, they become a commodity with the life of the original product extended beyond the intended use.

#### **TEHA-STC Conference**

The Texas Environmental Health Association – South Texas Chapter's (TEHA-STC) Annual Educational Conference is held every December



and brings attendees, vendors and speakers to the Island during our non-peak season. The EHS Department has been responsible for bringing the conference to SPI for the past 10 years. The conference provides continuing education hours, training and certification for Code Enforcement Officers, Registered Sanitarians, Health Inspectors, Animal Control Officers, and Pesticide Applicators. Current board members include Secretary Victor Baldovinos and Presidentelect David Travis. The 2013 Annual Educational Conference will mark the 10th anniversary of the South Texas Chapter, and we look forward to many more years of success!

## **Community Shredding Event**



The South Padre Island Chamber of Commerce in conjunction with the City's EHS Department, Keep South Padre Island Beautiful Committee, the Better Business Bureau of the Rio Grande Valley, the US Postal Service and Valley Shredding Services of Los Fresnos, coordinated the first community shredding event in April. The public was invited to drop off documents that were shredded on site with the latest in secure paper shredding technology. Those who participated, drove up with sensitive paperwork and drove away with the peace of mind that their documents containing personal information were no longer taking up valuable storage space and were safely destroyed and reserved for recycling.

## **Christmas Tree Recycling**



The City accepted Christmas trees for recycling in December and January. The trees were collected at the Saturday recycling drop-off site by the old City Hall and also picked up from the rights-of-way. The 42 trees collected were turned into mulch that was then made available to the public. This process reduces landfill waste and allows the reuse of the product.



#### **Anti-litter Beach Program**

The "Treasure It, Don't Trash It" antilitter beach program was created to reduce littering on our beautiful beach. The program was in effect from May 27- September 2, 2013. EHS hired two litter patrol inspectors to educate beachgoers on keeping our beautiful beaches clean and enforce local ordinance violations. The inspectors issued 328 warnings and 45 citations for "Glass on Beach". while also issuing 301 warnings and 16 citations for "Littering". Inspectors also passed out table tents to hotels, motels, property management companies and placed them on dining tables of local restaurants that publicized common beachrelated violations. The program was a tremendous success, with violations declining throughout the summer. Staff patrolling the beach saw significantly less trash than last summer, even with an increase of visitors frequenting the beaches this year. Additionally, volunteers from The University of Texas at Brownsville, Surfrider Foundation - South Texas Chapter, Keep South Padre Island Beautiful Committee, Sierra Club and a local citizen targeted four heavily populated beach locations to educate visitors, remove trash from the beach, and hand out trash bags to beachgoers.





## **Recycle Land**

The Keep SPI Beautiful Committee and the City's EHS Department hosted another successful Recycle Land Event in November 2012. The event collected glass, electronic waste, plastic, cardboard, aluminum, tin and paper. Organizations, including the Keep SPI Beautiful

Committee, The Art Affair, Surfrider Foundation - South Texas Chapter, Sea Turtle, Inc. and Home Depot also educated participants on the impact of recycling, how to recycle, and the negative impacts of polluting our ecosystem. The Recycle Land Event has had an increase in participants each year!

# **Finance** Department

### **Master Lease Agreement**

A Master Lease Agreement was approved in November 2012 with Merchants Leasing, as part of a fleet replacement program approved by Council in May 2012. We received the first of the leased vehicles in February 2013, which were outfitted and placed in service for use prior to Spring Break. Terms of the individual leases were finalized and all new leased vehicles have been received and placed in service.

#### **IRS Audit**

The South Padre Island EDC was selected for audit by the Internal Revenue Service. The finance department collected and organized all information requested. The IRS completed the audit in a timely manner and found the EDC to be in compliance with IRS regulations.

#### **HB 3042**

The passage of House Bill 3042 allows the City to receive an additional 1% for a total of 2% of the state's portion of the hotel motel tax. The two percent in funding is allocated for cleaning, maintenance of, and erosion control of the City's beaches. The Finance Department assisted in compiling the necessary data in a timely manner, so it could be presented by the City's lobbyist to our state legislators.

## **Updates/Planning for New Fire Department Schedules**

The Fire Department will institute a new Quad-Weekly work schedule

beginning in October 2013. Finance worked together with TimeClock Plus to acquire and setup the additional software module needed to implement the new work schedule.

## **Electronic Paystubs**

In order to promote efficiency and reduce waste, paystubs will begin to be emailed to employees next fiscal year. Finance and Information Services worked together with Incode to obtain and place in service the additional software module needed to email the paystubs.

## **City Auctions**

Auctions of the City's surplus items have been assigned to the Finance Department. In the most recent auction 91 items were sold for a total gross of \$24,638.66.

## **Convention Centre Renovation & Expansion**

Finance Department collaborating with Estrada Hinojosa, the City's financial advisors, to fund the renovation and expansion of the Convention Centre with the sale of revenue bonds.

#### **HOT Collections**

Hotel Occupancy Tax (HOT) collections and auditing services were outsourced to MuniServices, LLC. The Finance Department assisted with MuniServices in their analysis of Hotel Occupancy Tax payments for the past four years for auditing purposes.

# Fire Department

## Chief Baskett Resigns, Fire **Fighter Smith Promoted**

Fire Chief Burney Baskett provided the City his resignation with June 28, 2013 being his last day of service to SPI. Chief Baskett was offered the Fire Chief position at Copperas Cove. Chief Baskett did an incredible job during his tenure at the City receiving a letter of commendation, being instrumental in the City winning the TML Excellence Award in public safety, and transforming his department into one of the finest fire departments.



Fire **Fighter** Marcus Smith selected was to be the new Fire Chief. Smith served the City of Lancaster, Texas from 1984 to 2013 and retired

from the Lancaster Fire Department as a Captain prior to accepting a position with SPI. He also served his hometown of Wilmer, Texas as its Fire Chief from 2005 to 2012 to help his community as his schedule would allow. Smith has an advanced firefighter certification, is a licensed paramedic and is an emergency medical service instructor. His 37 years of experience include ten years as a volunteer and 28 years as a career firefighter. Smith joined the SPI Fire Department on March 1, 2013 and began serving as Fire Chief starting June 29, 2013.

## **Resident Donates Jeep** to SPI Fire Department

A local resident dropped by the Station just before Christmas and donated a rebuilt 1984 Jeep. It is the right color, too! After receiving its decals and lights, it was put into service for Spring Break as a rapid EMS response unit.

## **Gulf Coast Regional Lifeguard Competition**



The SPI Beach Patrol competed in the Gulf Coast Regional Lifeguard Competition held in Galveston in June 2013. Our team of four lifequards finished 3rd overall, qualifying the team to be considered for "Team Texas" at the national competition in August. The team members were: George Brown, Hayden Jones, Kendrick McCormack, and Dillon Connelly, who were accompanied by Beach Patrol Coordinator Jim Pigg. The Galveston competition is one of eight regional contests preceding the United States Lifesaving Association National Championships held each August in California. The team competed in areas including Swim Rescue, Paddle Rescue, Rescue board, beach flags, rescue race and ironman. The Gulf Coast includes Galveston, Austin, and Corpus Christi.

#### **Fitness Monitoring**

For the past three years, the Fire Department has conducting an annual test to monitor the progress of the physical fitness program. In the beginning, physical fitness participation was voluntary and unorganized, with no set time and limited equipment. Lt. N. Waters and Firefighter J. Barker created a fitness chart showing the progress. The SPI Fire Department employees have been getting fit, with 19 percent of the Fire Department reaching Superior fitness this year, up from zero percent in 2011 and 2012. Additionally, with the fully equipped gym now a part of the new Fire Station No. 1, physical training is now mandatory.

The exercise helps the various agencies practice coordination during a simulated rescue of an incident resulting in fire and significant injuries to 8+ persons in the water in order to identify strengths, gap, and best practices in emergency response and foster expanded partnerships through professional interaction.

# **Public** Works



City of South Padre Island Public Works Department 2012-2013



The old Public Works conference room was converted into two offices in January at a cost of \$4,668, including office furniture.



In November 2012 crews set up a Christmas tree, banners and rope lights on center medians on Padre Blvd. in preparation for the holidays.



A total 2,850 palm trees were trimmed in October 2012 and July 2013 at a total cost of \$32,775.



PW crews completed a crack sealing project as part of their street preventive maintenance.



Crews installed landscape timbers and rope to create a 10' safety access lane for maintenance, beach patrol, code and emergency vehicles by Clayton's, Wanna, Wanna, & Saida Towers. This lane is in use from Memorial Day thru Labor Day. It will be re-installed in March for Spring Break, as well.



In June 2013, a contractor and PW relocated 10 beach flag warning poles that were being covered by growing dunes.



In May 2013, PW installed solar powered advance warning signs off Padre Blvd. by new Fire Station No. 1. These signs help fire trucks safely access Padre Blvd. and warn motorists that emergency vehicles are approaching.



In October 2012, Beach Maintenance Crew installed Mobi Mats donated to the City by the Texas General Land Office.



In December 2012, PW celebrated the retirement of Hector Torres who served the South Padre Island community for 25 years.



In May 2013, PW replaced railroad ties and timbers on the second median near the causeway. They also added ground cover and adjusted sprinklers to help beautify the median.



In August 2013, faded street signs were replaced. South-facing street signs fade from extensive sun expsure, making them difficult to read, particularly at night.



Crews installed signage and orange fencing at several designated locations for Spring Break 2013.



The Laguna Madre Water District cleaned storm sewer inlets and lines in September 2013 at a cost of \$15,000.



Full reconstruction of E. Huisache and spot repairs on Laguna and Gulf Blvd. started in August 2013 and will be completed in October 2013. Additional work is being done to repair pavement on Gulf Blvd., Laguna Blvd., Acapulco, Campeche and Morningside. Design of parking and bike/pedestrian improvements on Gulf Blvd. is also part of the project.

#### Ridership

According to the FY2012 Texas Rural Transit Districts Peer-To-Peer Comparison and Performance Data reports, The WAVE had the 2nd highest ridership among the state's 39 rural systems. The only system with higher ridership has a population of almost 62,000 and covers 248 square miles. The WAVE's total ridership for FY2012 was 593,404. The average ridership for all rural systems in Texas for FY2012 was 181,017.

#### **New Regional Route**

The City of Brownsville, the City of McAllen, the City of South Padre Island, and Valley Transit Company have established a three legged intercity route that will provide non-stop intercity service from UTPA to McAllen, from Brownsville to McAllen, and from Brownsville to South Padre Island. Connecting regional hubs in the area and a commitment to seamless transportation were the primary driving forces for this project.

An unveiling of the new project was held in August 2013 at the La Plaza at Brownsville terminal located in Brownsville. television and radio stations were present and interviewed the various transit system directors as well as other distinguished attendees.




#### **New Buses**
