



Discussion and action on Padre Boulevard design

ITEM BACKGROUND

On June 10, 2014, the DSRTF had a workshop on Padre Blvd design and median extension. At the meeting, the DSRTF requested staff to provide few alternatives of Padre Blvd design. The major issue was to determine if the City wanted to have front-parking along Padre Blvd.

COMPREHENSIVE PLAN GOAL

The City's Comprehensive Plan lays out goals and objectives to enhance quality of life. One of the goals is to enhance physical environment (3.J), while one of the recommended actions includes enhancing the standards and appearance of public rights-of-way and properties (3.7).

RECOMMENDATIONS/COMMENTS

Staff recommends DSRTF consider the following three alternatives and, if front-parking along Padre Blvd is chosen to be a preferred alternative, contemplate the road segment(s) that the front-parking will be allowed. Also, discussions, about the preferred width of median in the road segments with 200' ROW, are needed.
