

**ITEM BACKGROUND**

Port Isabel, South Padre Island Reefing Project Mission Statement:

This artificial reefing project, a joint effort between local stakeholders, conservation groups, and Texas Parks and Wildlife Department will be comprised of a 320 ac. reefing site located in State waters a few miles Northeast of the South Padre Island Jetties. Initially provided with 800 concrete culverts and concrete rip rap, the site will provide enhanced recreational fishing and juvenile fish nursery/survival habitat. This reef is envisioned as a multi-year, ongoing project with multiple deployments and the goal of continued improvement of the site to its capacity with possible expansion.
