# MINUTES OF CITY COUNCIL REGULAR MEETING CITY OF SOUTH PADRE ISLAND

## **WEDNESDAY, AUGUST 2, 2023**

#### 1.CALL TO ORDER

The City Council Members of the City of South Padre Island, Texas held a Regular City Council Meeting on Wednesday, August 2, 2023 at the Municipal Complex Building, 2 Floor, 4601 Padre Boulevard, South Padre Island, Texas. Mayor McNulty called the meeting to order at 5:30 p.m. A quorum was present: Mayor Patrick McNulty, Council Members Ken Medders, and Rees Lanston, and Kerry Schwartz.

#### 2.PLEDGE OF ALLEGIANCE AND TEXAS PLEDGE

Mayor McNulty led the Pledge of Allegiance and the Texas Pledge.

#### **4.APPROVE CONSENT AGENDA:**

Council Member Medders made a motion, seconded by Council Member Langston to approve Consent Agenda Items 4.1 through 4.4. Motion passed unanimously.

## 5.2. UPDATE AND DISCUSSION REGARDING CITY CROSSWALKS. (MEDDERS)

Public Works Director Alex Sanchez updated the Council regarding the City crosswalk enhancements. The Texas Department of Transportation (TXDOT) has approved the following components:

- Existing crosswalks will be enhanced decorative pavement crosswalks
- Yield Triangle to Stop Bars
- Additional pedestrian crossing markings to existing crosswalks

All new payment markings will be done after TXDOT repaves Padre Boulevard.

Signage Improvements approved:

- Replace all signed from yield to stop
- Upgrades to the Edge-Lit LED Flashers to RRFBs on the south side
- Center Stop for pedestrians enhanced with static lights

TXDOT did NOT approve the following:

- Changing yellow RRFBs to Red RRFB
- In-ground lighting

# 5.3. PRESENTATION AND DISCUSSION REGARDING THE NEW MARKETING PLAN FOR FY23/24. (HENRY)

CVB Director Blake Henry updated the City Council on the new marketing plan for 2023/2024.

The Escape Campaign was created by the Zimmerman Agency and was approved by the Convention and Visitors Advisory Board in July. The target audience was identified to formulate and strategize the marketing plan.

Replacing the "This or That" Campaign was used for approximately two years.

Data analytics are provided by Predictive Data Lab using nine data sources. Locations, a review of summer marketing efforts, and upcoming fall events were presented.

Promoting Spring Break has started earlier than in previous years with an increase of \$100,000 to match the collegiate spring break. A third-party promoter will be managing the collegiate events and family-friendly events. Activation to promote is schedule to begin in September.

Council Member Medders made a motion, seconded by Council Member Schwartz to approve the draft of Chapter 7 of the City of South Padre Island Code of Ordinances as recommended by the AdHoc Committee. Motion passed unanimously.

5.5. DISCUSSION AND POSSIBLE ACTION TO APPROVE THE ORDER OF GENERAL ELECTION FOR MUNICIPALITIES FOR NOVEMBER 7, 2023 GENERAL ELECTION FOR THE PURPOSE OF ELECTING TWO CITY COUNCIL MEMBERS (MAYOR AND PLACE 4). (SOTO)

Council Member Medders made a motion, seconded by Council Member Schwartz to approve the Order of General Election for Municipalities for November 7, 2023 General Election for the purpose of electing two City Council Members (Mayor and Place 4). Motion passed unanimously.
