1. CALL TO ORDER

Council member Schwartz made a motion, seconded by Council Member Graves to approve Consent Agenda Items 4.1 through 4.5. Motion passed unanimously.

5.1. DISCUSSION AND POSSIBLE ACTION TO APPROVE THE SPI HOLIDAY SANDCASTLE VILLAGE SPECIAL EVENT PERMIT FOR 1 YEAR. (HUFFMAN)

Council Member Graves made a motion, seconded by Council Member Schwartz to approve the SPI Holiday Sandcastle Village special event permit for 1 year. Motion passed unanimously by Council Member Ken Medders, Rees Langston, Lisa Graves, and Kerry Schwartz.

5.2. DISCUSSION AND ACTION TO APPROVE THE RANKING AND SUBMISSION OF THE COASTAL MANAGEMENT PROGRAM (CMP) CYCLE 31 GRANT PROPOSALS AND ALLOW THE MAYOR AND CITY MANAGER TO EXECUTE RELATED DOCUMENTS. (BOBURKA)

Council Member Medders made a motion, seconded by Council Member Schwartz to approve ranking and submission for the Coastal Management Program (CMP)'s Cycle 31 proposals. Motion passed unanimously by Council Member Ken Medders, Rees Langston, Lisa Graves, and Kerry Schwartz.

5.3. DISCUSSION AND ACTION REGARDING A BEACH AND DUNE PERMIT FOR 8454 BREAKERS BOULEVARD REGARDING DUNE MITIGATION. (BOBURKA)

Council Member Medders made a motion, seconded by Council Member Graves to approve a Beach and Dune Application for 8454 Breakers Boulevard. Motion passed unanimously by Council Member Ken Medders, Rees Langston, Lisa Graves, and Kerry Schwartz.

5.4. DISCUSSION AND POSSIBLE ACTION REGARDING THE REPLACEMENT OF CITY HALL CHILLER COMPRESSOR #1 AND TO APPROVE THE CORRESPONDING BUDGET AMENDMENT IN THE AMOUNT OF \$280,000 FROM THE FACILITY MAINTENANCE FUND. (WILSON)

Council Member Schwartz made a motion, seconded by Council Member Graves to approve replacement of City Hall chiller compressor #1 and the corresponding budget amendment in the amount of \$280,000 from the Facility Maintenance Fund. Motion passed unanimously.

5.5. DISCUSSION AND POSSIBLE ACTION REGARDING THE REPLACEMENT OF THE CITY HALL FIRE ALARM PANEL AND INITIATION DEVICES AND APPROVAL OF A BUDGET AMENDMENT IN THE AMOUNT UP TO \$32,000. (WILSON)

Council Member Ricco made a motion, seconded by Council Member Graves to approve replacement of City Hall fire alarm panel and initiation devices and a budget amendment in the amount up to \$32,000. Motion passed unanimously.

5.6. DISCUSSION AND POSSIBLE ACTION REGARDING CHANGES RELATED TO THE COMPLETION OF THE LAGUNA BLVD PUNCH LIST AND APPROVE CHANGE ORDER NO. 3. (WILSON)

This item was pulled.

5.7. DISCUSSION AND POSSIBLE ACTION TO APPROVE A BUDGET AMENDMENT IN THE AMOUNT OF \$17,800 FOR SECURITY ENHANCEMENTS OF THE FIRE DEPARTMENT BUILDING ACCESS CONTROL AND REPAIRS OF THE INTERCOM SYSTEM. (MARTINEZ)

Council Member Ricco made a motion, seconded by Council Member Schwartz to approve a budget amendment in the amount of \$17,800 for security enhancements of the Fire Department Building access control and repairs of the intercom system. Motion passed unanimously.

5.8. DISCUSSION AND POSSIBLE ACTION TO APPROVE A BUDGET AMENDMENT IN THE AMOUNT OF \$34,651.15 TO PURCHASE THE REPLACEMENT OF 2 ENTERPRISE DELL SERVERS, 2 APC BATTERY BACKUP UNITS, 3 WORK LAPTOPS AND 3 BACKPACKS. (MARTINEZ)

Council Member Schwartz made a motion, seconded by Council Member Graves to approve a budget amendment in the amount of \$34,651.15 to purchase the replacement of 2 Enterprise Dell servers, 2 APC battery backup units, 3 work laptops, and 3 backpacks. Motion passed unanimously.

5.9. DISCUSSION AND POSSIBLE ACTION TO APPROVE A BUDGET AMENDMENT FROM CVB EXCESS RESERVES IN THE AMOUNT UP TO \$300,000 TO BE USED FOR A SUMMER MEDIA PLAN FOR \$200,000 AND MEDIA BUY REPORTING FOR \$100,000. (HENRY)

Council Member Ricco made a motion, seconded by Council Member Schwartz to approve a budget amendment from CVB Excess Reserves in the amount up to \$300,000 to be used for a Summer Media Plan for \$200,000 and media buy reporting for \$100,000. Motion passed unanimously.
