1.CALL TO ORDER

4. REGULAR AGENDA

4.1. DISCUSSION AND ACTION TO ACCEPT THE SUBMISSION OF THE CAPITAL IMPROVEMENT PLAN (CIP) AS REQUIRED BY SECTION 5.09 OF THE HOME RULE CHARTER. (DELGADO)

Council Member Schwartz made a motion, seconded by Council Member Medders to accept the submission of the Capital Improvement Plan (CIP) as required by section 5.09 of the Home Rule Charter. Motion passed unanimously.

4.2. DISCUSSION AND ACTION TO ACKNOWLEDGE THE SUBMISSION OF THE 2025-26 PROPOSED BUDGET TO COMPLY WITH THE SIXTY (60) DAYS REQUIREMENT OF THE CITY OF SOUTH PADRE ISLAND HOME RULE CHARTER SECTION 5.02. (GIMENEZ)

Council Member Graves made a motion, seconded by Council Member Schwartz to acknowledge the submission of the 2025-26 proposed budget to comply with the sixty (60) days requirement of the City of South Padre Island Home Rule Charter section 5.02. Motion passed unanimously.

4.3. DISCUSSION AND ACTION TO APPROVE RESOLUTION NO. 2025-09 BY THE CITY COUNCIL OF THE CITY OF SOUTH PADRE ISLAND, TEXAS TO APPROVE THE PROPOSED TAX RATE FOR THE NOTICE OF THE MEETING TO VOTE ON THE 2025 TAX RATE. (GIMENEZ)

Council Member Schwartz made a motion, seconded by Council Member Graves to approve Resolution No. 2025-09 by the City Council of the City of South Padre Island to approve the proposed tax rate for the notice of the meeting to vote on the 2025 tax rate. Motion passed unanimously.

Council Member Schwartz made a motion, seconded by Council Medders to authorize the City Manager to enter into a contract with Deckard Technologies, the best qualified bidder for Local Hotel Occupancy Tax Reporting, Collection and Administration Services. Motion passed unanimously.
