DISCUSSION AND POSSIBLE ACTION TO REQUEST THE PLANNING & ZONING COMMISSION TO REVIEW AND PROVIDE RECOMMENDATIONS TO THE CITY COUNCIL REGARDING THE CONSIDERATION TO DESIGNATE THE AREA WEST OF PADRE BOULEVARD, FROM THE NORTH SIDE OF THE CONVENTION CENTER TO THE SOUTH SIDE OF SEA TURTLE INC. AS THE SPI ECO TOURISM DISTRICT. (SCHWARTZ)

Council Member Ricco made a motion, seconded by Council Member Graves, to request that the Planning & Zoning Commission review and provide recommendations to the City Council regarding the consideration to designate the area west of Padre Boulevard, from the north side of the Convention Center to the south side of Sea Turtle Inc. as the SPI Eco Tourism District. Motion passed unanimously.

6.4. DISCUSSION AND POSSIBLE ACTION TO APPROVE A CONTRACT AMENDMENT WITH GREENHAUS IN THE AMOUNT OF \$200,000 FOR ADDITIONAL NET MEDIA COSTS AND AGENCY MEDIA FEES. (TREVINO)

Council Member Ricco made a motion, seconded by Council Member Graves, to approve a contract amendment with Greenhaus in the amount of \$200,000 for additional Net Media Costs and Agency Media Fees. Motion passed unanimously.

6.5. DISCUSSION AND POSSIBLE ACTION TO APPROVE A BUDGET AMENDMENT FROM THE GENERAL FUND EXCESS RESERVES OF \$99,300.0 TO COVER THE CURRENT OVER-BUDGET SITUATION AND ESTIMATED COST OF REPAIRS AND MAINTENANCE FOR VARIOUS CITY VEHICLES FOR THE REMAINDER OF THE FISCAL YEAR. (SANCHEZ)

Council Member Ricco made a motion, seconded by Council Member Schwartz, to a budget amendment from the General Fund Excess Reserves of \$99,300.0 to cover the current over-budget situation and estimated cost of repairs and maintenance for various city vehicles for the remainder of the fiscal year. Motion passed unanimously.

6.6. DISCUSSION AND POSSIBLE ACTION TO APPROVE A BUDGET AMENDMENT FROM THE TAX INCREMENT REINVESTMENT ZONE (TIRZ) FUND FOR THE AMOUNT OF \$25,900.00 TO PURCHASE OF FOUR DECORATIVE HOLOPHANE LAMP. (SANCHEZ)

Council Member Ricco made a motion, seconded by Council Member Schwartz, to a budget amendment from the Tax Increment Reinvestment Zone (TIRZ) fund for the amount of \$25,900.00 to purchase of four decorative holophane lamp. Motion passed unanimously.

6.7. DISCUSSION AND ACTION TO AUTHORIZE THE CITY MANAGER TO ENTER INTO A CONTRACT WITH THE BEST-QUALIFIED BIDDER FOR THE PLPW-202501 SPI PR-100 PARKING LOT IMPROVEMENTS PROJECT, AND TO APPROVE A BUDGET AMENDMENT IN AN AMOUNT \$569,190.32 FROM FUND 51 TIRZ. (SANCHEZ)

Council Member Graves made a motion, seconded by Council Member Ricco to table this item. Motion passed unanimously.

Council Member Schwartz made a motion, seconded by Council Member Graves, to approve budget enhancement in the amount of \$10,000 from excess reserves to purchase new mobichairs. Motion passed unanimously.

Council Member Graves made a motion, seconded by Council Member Ricco accept the Side Street Reconstruction Projects. Motion passed unanimously.

6.10. DISCUSSION AND ACTION TO AUTHORIZE THE CITY MANAGER TO NEGOTIATE A CONTRACT WITH THE HIGHEST RANKED ENGINEERING FIRM FOR CITY SIDE STREET RECONSTRUCTION IMPROVEMENTS. (SANCHEZ)

Council Member Ricco made a motion, seconded by Council Member Schwartz to authorize the City Manager to negotiate a contract with Kimley Horn, the highest ranked engineering firm for City Side Street Reconstruction Improvements. Motion passed unanimously.
