ORDINANCE NO. 12-10

AN ORDINANCE OF THE CITY OF SOUTH PADRE ISLAND, TEXAS, AMENDING CHAPTER 3 OF THE CODE OF ORDINANCES (ANIMALS AND FOWL); PROVIDING FOR AMENDMENTS AND ADDITIONS; SPECIFICALLY, OF ADDING 3-1.1 **DEFINITION** LIVESTOCK; PROHIBITION OF LIVESTOCK; AMENDED 3-2 FOWL PROHIBITED DEFINITION; ADDING 3-4.1 DEFINITION OF DOG BITE; AMENDING 3-5 PROVIDING A TIME FRAME WITHIN WHICH TO VACCINATE DOGS FOR RABIES; AMENDING 3-11 DEFINITION OF EXTERMINATION; ADDING 3-12.1 DESIGNATED IMPOUNDMENT FACILITY; AMENDING SECTIONS REGARDING ANIMAL REDEMPTION; ADDING 3-22.1 INTERFERENCE WITH CODE ENFORCEMENT OFFICER; ADDING 3-24 DEFINITION OF CAT BITE; AMENDING 3-32 BARKING DOG AND CRYING CAT COMPLAINTS; RE-PUBLISHING CHAPTER 3 OF THE CODE OF ORDINANCES OF SOUTH PADRE ISLAND, TEXAS AS AMENDED: PROVIDING FOR A PENALTY OF FIVE HUNDRED DOLLARS (\$500.00) FOR ANY VIOLATION PROVIDING FOR SEVERABILITY AND THE REPEAL OF CONFLICTING ORDINANCES; **PROVIDING** FOR PUBLICATION IN CAPTION FORM.

WHEREAS, the City of South Padre Island has passed an Ordinance regulating Animals and Fowl, which Ordinance has been codified as Chapter 3 of the Code of Ordinances of the City of South Padre Island, Texas;

WHEREAS, the City of South Padre Island, Texas has determined that said Chapter 3 should be further amended.

NOW THEREFORE, BE IT ORDAINED BY CITY COUNCIL OF THE CITY OF SOUTH PADRE ISLAND, TEXAS:

<u>Section 1</u>. Chapter 3 of the Code of Ordinances for the City of South Padre Island is hereby further amended as more fully set forth in Exhibit "A" hereto attached and by reference herein incorporated for all purposes, which is a true and correct copy of Chapter 3 as previously enacted with the amendments hereby adopted to Chapter 3 being underlined and those provisions hereby deleted or replaced having a strike-through.

<u>Section 2</u>. A true and correct copy of Chapter 3 of the Code of Ordinances for the City of South Padre Island as amended by Section 1 hereof as it will appear in the Code of Ordinances is hereby attached and by reference herein incorporated for all purposes and the same is hereby re-published as Chapter 3 of the Code of Ordinances for the City of South Padre Island.

Section 3. Any violation of this Ordinance may be punished by a fine not to exceed Five Hundred Dollars (\$500.00) for each offense or for each day such offense shall continue

and the penalty provisions of Section 21-1 of the Code of Ordinances is hereby adopted and incorporated for all purposes.

<u>Section 4</u>. If for any reason any section, paragraph, subdivision, clause, phrase, word or provision of this Ordinance shall be held invalid or unconstitutional by final judgment of a court of competent jurisdiction, it shall no affect any other section, paragraph, subdivision clause, phrase, word or provision of this Ordinance for it is the definite intent of this City council that every section, paragraph, subdivision, clause, phrase, word or provision hereof be given full force and effect for its purpose.

<u>Section 5</u>. This Ordinance shall become effective when published in caption form.
