#### I. CALL TO ORDER

Mayor Pinkerton informed that HB 1831 was passed and signed by the Governor on June 19 and will take effect on September 1, 2009. The bill allows the governor, judges, and mayors to compel residents to evacuate on a mandatory evacuation and authorizes the use of reasonable force to do so and to those refusing to evacuate, to be civilly liable for rescue costs.
