Finance Director Rodrigo Gimenez showed a power point presentation outlining the highlights of the Mid-Year Budget Review. Rodrigo stated that the General Fund currently had an excess reserve of \$296,393 and the Convention Centre/Hotel Motel Fund had \$1,070,684 (note: \$1 million of the latter has been allocated to the Convention Centre Renovation Project). These figures are in excess of the six month reserve requirement as set forth by the Home Rule Charter.
