DISCUSSION:

On February 10, 2015, Mr. John Ortiz, applied for a variance on a color (Dynamic Blue (SW6958)) that will be applied to a section of the Wingstop building facade.

COLOR ISSUE

The proposed Dynamic Blue (SW6958) does not exist in our color palette. Although similar color hues (Dockside Blue (SW7601), Festoon Aqua (SW0019), and Rain (SW6219)) exists for building body color, those are not the same color the owner wants to apply in the building.



RECOMMENDATION

The proposed color is a part of a franchise color and the same color was applied to the city's fire station. Staff recommends the DSRTF approve the usage of the proposed Dynamic Blue (SW6958) as a color that will be applied to a section of the Wingstop building facade.


