MINUTES OF CITY COUNCIL REGULAR MEETING CITY OF SOUTH PADRE ISLAND

WEDNESDAY, JULY 20, 2022

1.CALL TO ORDER

The City Council Members of the City of South Padre Island, Texas held a Special Meeting on Wednesday, July 20, 2022 at the Municipal Complex Building, 2. Floor, 4601 Padre Boulevard, South Padre Island, Texas. Mayor McNulty called the meeting to order at 5:30 p.m. A quorum was present: Mayor Patrick McNulty, Council Members, Ken Medders, Kerry Schwartz, Joe Ricco, and Eva Jean Dalton.

6.REGULAR AGENDA

6.1. DISCUSSION AND POSSIBLE ACTION TO ACCEPT THE UNITED STATES DEPARTMENT OF COMMERCE'S ECONOMIC DEVELOPMENT ADMINISTRATION \$1.5 MILLION GRANT FOR THE CONSTRUCTION OF THE HISTORICAL MUSEUM OF SOUTH PADRE ISLAND. (RICCO)

Council Member Ricco made a motion, seconded by Council Member Medders to accept the United States Department of Commerce's Economic Development Administration \$1.5 Million Grant for the construction of the Historical Museum of South Padre Island including the City of South Padre Island's twenty percent (20%) match . Motion carried unanimously.

6.2. DISCUSSION AND POSSIBLE ACTION TO APPROVE RESOLUTION NO. 2022-10 PROHIBITING CITY COUNCIL MEMBERS FROM INFLUENCING HOW A CITY COMMITTEE, BOARD, COMMISSIONS, OR TASK FORCE REGARDING VOTING. (SCHWARTZ)

This item was pulled to the Aug. 3, 2022 Regular City Council Meeting.

6.3. DISCUSSION AND ACTION TO AUTHORIZE THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH HANSON PROFESSIONAL SERVICES INC. FOR ADDITIONAL SERVICES RELATED TO THE WIND AND WATER SPORTS VENUE BIOLOGICAL ASSESSMENT AND UNITED STATES ARMY CORPS OF ENGINEER PERMITTING. (BOBURKA)

Council Member Ricco made a motion, seconded by Council Member Medders to authorize the City Manager to execute an agreement with Hanson Professional Services Inc., for additional services related to the Wind and Water Sports Venue biological assessment and United States Army Corps of Engineer permitting. Motion carried unanimously.

6.4. DISCUSSION AND ACTION ON THE FINAL LAYOUT FOR SEA ISLAND CIRCLE IMPROVEMENTS PARTIALLY FUNDED UNDER THE COASTAL MANAGEMENT PROGRAM (CMP)'S CYCLE 26. (BOBURKA)

Council Member Ricco made a motion, seconded by Council Member Schwartz to approve the final layout for Sea Island Circle Improvements partially funded under the Coastal Management Program (CMP)'s Cycle 26. Motion carried unanimously.

6.5. DISCUSSION AND POSSIBLE ACTION TO APPROVE THE FIRST READING OF ORDINANCE NO. 22-04 AMENDING CHAPTER 11 BY ADDING SECTION 11-300 AND 11-301 PROHIBITING THE RENTING, LEASING OR SUBLEASING OF ONLY A SWIMMING POOL OR SPA WITHOUT THE RENTING OR LEASING OF AN OVERNIGHT STAY IN DISTRICTS A, B-2, AND E. (MCNULTY)

Council Member Ricco made a motion, seconded by Council Member Schwartz to approve the first reading of Ordinance No. 22-04 amending Chapter 11 by adding Section 11-300 and 11-301 prohibiting the renting, leasing or subleasing of only a swimming pool or spa without the renting or leasing of an overnight stay in districts A, B-2, and E. Motion passes on a 4 to 1 vote with Council Member Dalton casting a nay vote.

6.6. DISCUSSION AND POSSIBLE ACTION TO APPROVE THE SPI HOLIDAY SANDCASTLE VILLAGE SPECIAL EVENT PERMIT FOR 1 YEAR. (HUFFMAN)

Mayor McNulty and Council Member Ricco abstained from item 6.6.

Council Member Medders made a motion, seconded by Council Member Dalton to approve the SPI Holiday Sandcastle Village Special Event Permit for 1 year contingent upon providing insurance policy. Motion passed unanimously.

7.ADJOURN.

There being no further business, Mayor Pro Tem Schwartz adjourned the meeting at 6:10 p.m.
