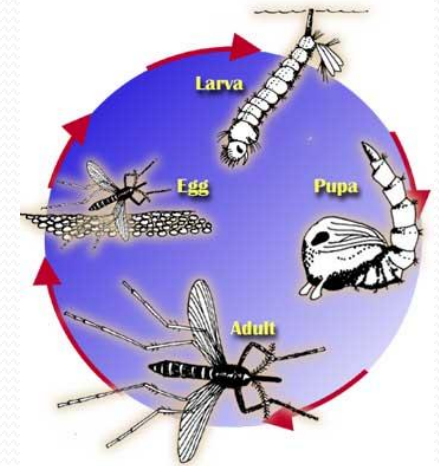

Remember the four D's in your defense against Mosquitoes: **DUSK/DAWN** are the times of day when you should try to stay indoors. This is when Mosquitoes are most active. **DRESS** in long sleeves and pants when you're outside. **DEET** (N,N-diethyl-m-toluamide) is an ingredient to look for in your insect repellent. Other approved repellents include picaridin, oil of lemon eucalyptus and IR3535. **DRAIN** standing water in your backyard and neighborhood – old tires, flowerpots and clogged rain gutters. These are mosquito breeding sites.
