

Bacteria multipy rapidly between 40 and 140 degrees farenheit. To keep food out of this "Danger Zone," keep cold food cold and hot food hot. Keep food cold in the refrigerator, in coolers, or on the serving line on ice. Keep hot food in the oven, in heated chafing dishes. or in preheated steam tables, warming trays and/or slow cookers.



Mosquitoes are pests that can spread disease and itchy discomfort. Getting rid of them in a small area is easier than you might think; here are some pointers to assist your battle against them.

Dump or flush out any stagnant water sources in your yard. Examples of mosquito breeding grounds include old tires, driveway puddles, unfiltered fish ponds, empty flowerpots, and any item that can hold water for more than a few days at a time. If you're inundated by mosquitoes/gnats due to standing water from street curbs, drainage ditches or other pools you can't really control- toss in a couple of toilet bowl tablets. This seems to work.
