MINUTES CITY COUNCIL REGULAR MEETING CITY OF SOUTH PADRE ISLAND

WEDNESDAY, AUGUST 4, 2021

1.CALL TO ORDER

The City Council Members of the City of South Padre Island, Texas held a Regular Meeting on Wednesday, August 4, 2021 at the Municipal Complex Building, 2. Floor, 4601 Padre Boulevard, South Padre Island, Texas. DISCUSSION AND POSSIBLE ACTION REGARDING THE REQUEST TO REZONE LOT 3 BLOCK 202, FIESTA ISLES SUBDIVISION (PADRE BEACH, SECTION XII) FROM DISTRICT "E" - LOW DENSITY RESIDENTIAL - SINGLE-FAMILY AND TOWNHOUSE DWELLING DISTRICT TO "NC" NEIGHBORHOOD CROSSING CHARACTER ZONE. (YEHUDA AZOULAY, OWNER) (SANCHEZ)

Council Member Dalton made a motion to approve the request to rezone Lot 3, Block 2020, Fiesta Isles Subdivision (Padre Beach, Section XII) from District "E" - Low Density Residential - Single-Family and Townhouse Dwelling District to "NC" Neighbordhood Crossing Character Zone. Motion died due to a lack of a second.

Council Member Ricco made a motion to deny the request to rezone Lot 3, Block 2020, Fiesta Isles Subdivision (Padre Beach, Section XII) from District "E" - Low Density Residential - Single-Family and Townhouse Dwelling District to "NC" Neighbordhood Crossing Character Zone. Motion died due to a lack of a second.

Council Member Dalton made a motion, seconded by Mayor McNulty to table this item and have it return at the next Regular City Council Member. Motion passed unanimously.

6.3. PUBLIC HEARING REGARDING THE 2021/2022 – 2025/2026 CAPITAL IMPROVEMENT PLAN (CIP). (DELGADO)

6.4. DISCUSSION AND POSSIBLE ACTION APPROVING THE PURCHASE OF SHADE STRUCTURES IN THE AMOUNT OF \$97,000 TO BE INSTALLED AT THE JOHN L. TOMPKINS PARK AS PART OF PHASE II GRANT RECEIVED FROM TEXAS PARKS AND WILDLIFE IN 2019. (HUFFMAN)

Council Member Ricco made a motion, seconded by Council Member Schwartz approving the purchase of shade structure in the amount of \$97,000 to be installed at the John L. Tompkins Park as part of Phase II grant. Motion carried unanimously.

6.5. DISCUSSION AND POSSIBLE ACTION TO APPROVE A BUDGET AMENDMENT IN THE AMOUNT OF \$333,000 FROM THE ECONOMIC DEVELOPMENT CORPORATION EXCESS RESERVES TO PROVIDE FUNDING FOR THE SECOND CAUSEWAY ENVIRONMENTAL IMPACT STUDY. (LAPEYRE)

Council Member Ricco made a motion, seconded by Council Member Dalton to approve a budget amendment in the amount of \$333,000 from the Economic Development Corporation Excess Reserves to provide funding for the second causeway environment impact study. Motion carried unanimously.

6.6. DISCUSSION AND POSSIBLE ACTION TO APPROVE THE TEXAS MUSIC SCENE MARKETING BUY IN THE AMOUNT OF \$108,000 FOR THE FY 2021/2022. (CAUM)

Council Member Dalton made a motion, seconded by Council Member Schwartz to approve the Texas Music Scene Marketing buy in the amount of \$108,000 for the fiscal year 2021-2022. Motion passed on a 2 to 0 vote with Mayor McNulty and Council Members Ricco and Medders abstaining.

6.7. DISCUSSION AND POSSIBLE ACTION THAT A WORKSHOP BE SCHEDULED WITH THE LAGUNA MADRE WATER DISTRICT REGARDING INFRASTRUCTURE NEEDS AND IMPROVEMENTS. (MCNULTY)

Council Member Dalton made a motion, seconded by Council Member Ricco to schedule a workshop with the Laguna Madre Water District before September 1, 2021. Motion carried unanimously.

6.8. DISCUSSION AND POSSIBLE ACTION TO APPROVE A BUDGET AMENDMENT IN THE AMOUNT OF \$388,000 FROM EXCESS RESERVES GENERAL FUND REGARDING LAND ACQUISITION IN REGARDS TO 103, 105, AND 107 WEST MARS LANE, SOUTH PADRE ISLAND, TEXAS 78597 (SOUTH PADRE ISLAND - PADRE BEACH SUBDIVISION SECTION IX LOTS 2 & 3, BLOCK 136.) (MCNULTY)

Council Member Ricco made a motion, seconded by Council Member Schwartz to approve a budget amendment in the amount of \$388,000 from Excess Reserves General Fund regarding land acquisition in regards to 103, 105, and 107 West Mars Lane, South Padre Island, Texas 78597 (South Padre Island - Padre Beach Subdivision Section IX Lots 2 & 3, Block 136.) Motion carried unanimously.

6.9. DISCUSSION AND POSSIBLE ACTION TO APPROVE ORDER OF GENERAL ELECTION FOR MUNICIPALITIES FOR THE NOVEMBER 2, 2021 GENERAL ELECTION FOR THE PURPOSE OF ELECTING TWO COUNCIL MEMBERS (PLACE 3 AND PLACE 5). (SOTO)

Council Member Schwartz made a motion, seconded by Council Member Medders ordering the General Election for Municipalities for the November 2, 2021 General Election for the purpose of election two Council Members (Place 3 and Place 5). Motion carried unanimously.
