

The Shoreline Task Force of the City of South Padre Island, Texas held a regular meeting on Monday, March 26, 2018, at the Municipal Complex Building, 2nd Floor, 4601 Padre Boulevard, South Padre Island Texas. Vice Chairman Virginia Guillot, called the meeting to order at 3:00 p.m. A quorum was present: Task Force Members, Norma Trevino, Troy Giles, Thoren Thorbjørnsen and Stormy Wall and were present at the meeting.

City staff members present were: Shoreline Management Director Brandon Hill, and Shoreline Program Coordinator Jose Manuel Aguilar, City Manager Susan Guthrie and Assistant City Manager Darla Jones.

Ms. Virginia Guillot led the Pledge of Allegiance.

III. Public Comments and Announcements.

IV. Approval of the April 9, 2018 meeting minutes.


