LICENSE & PERMIT BOND IS REQUIRED

Sec. 4-20 (A) Upon the granting of a building permit, a bond with good and sufficient sureties for a sum of not less than Ten Thousand (\$10,000) Dollars providing for the payment to the City and to any person or persons injured or damaged in person or property of the City, for all injuries and damages caused by, or growing out of or in any manner connected with such moving, demolition or construction, is required.
